- (3) Unfair treatment encountered by minorities in the judicial field. In the field of justice, the protection of whites is obvious. To be honest, there are two standards (one for whites and one for blacks). When the police routinely perform legal inspections, most of the people being inspected are ethnic minorities, who treat white people with one eye closed and one eye closed. The proportion of ethnic minorities in prisons is far greater than that of whites. A more absurd idea in Western countries is: "Reducing the fertility rate of black women means reducing the crime rate in society." Judging whether a person is suspected of crime by the color of the skin is one of the criteria used by the police in some western countries. Among the detainees with criminal facts, people of color are subject to more severe and severe penalties and punishments. The law also extremely safeguards the interests of white people. In some prisons, police abuse black people from time to time. What is more serious is that the police did not receive any legal punishment after death. - (4) The survival and employment of ethnic minorities face serious problems. In the western social income industry rankings, white households earn several times more than black households, and in the lowest level of social employment, black households account for far more of the lowest occupations in society than some whites. Among the top occupations in terms of social income, white occupations tend to be at the top. Under the same academic background, the average monthly income of ethnic minorities is only 40% or less of that of white people; most of white people have their own housing problems, while colored races are prohibitive. Racial discrimination is also reflected in the purchase of real estate. The interest rate of banks on black loans is much higher than that of white people, and the success rate of black loans is very low [15]. Some black people with a certain social status and some black college students with high education background are often questioned by local white police in terms of life, travel, shopping, etc., and they are often suspected of illegal activities such as stealing finances and defrauding goods. What is even more surprising is that among some large and powerful companies in the West and even the top 100 companies, no black person is employed in an executive position [19].

2.4. Characteristics of Current Western Racial Discrimination

- (1) All-round permeability. The development of racial discrimination in western countries to this day is no longer a single issue. Its reasons involve a wide range of factors, such as economic, political, cultural, educational, religious, media, and social development. These factors can affect a wide range and are highly permeable and can often affect the ideas and ideologies of several generations. It is a process that gradually occurs from "shallow to deep" and "implicitly" and continuously expands its influence.
- (2) Continuity and inheritance of racial discrimination. The relationship between people and the environment and education is interactive. The organization and action of cluster effects will undoubtedly exacerbate the cruelty of racial hatred [24].

2.5. The Causes of Current Western Exclusion




Figure 1. Investigation steps




Figure 2. Number of graduate students' opinions




Figure 3. Number of the opinions of Chinese living in the west opinions

4.2. Western States' Analysis of China's Anti-dumping and Western Media Reports




Figure 4. China suffers the weight of anti-dumping in the world




Figure 5. Proportion of Western media reports

digging into "crimes", it is better to focus on their own development issues, regain a rational and objective view of China, and sincerely seek mutually beneficial cooperation.
